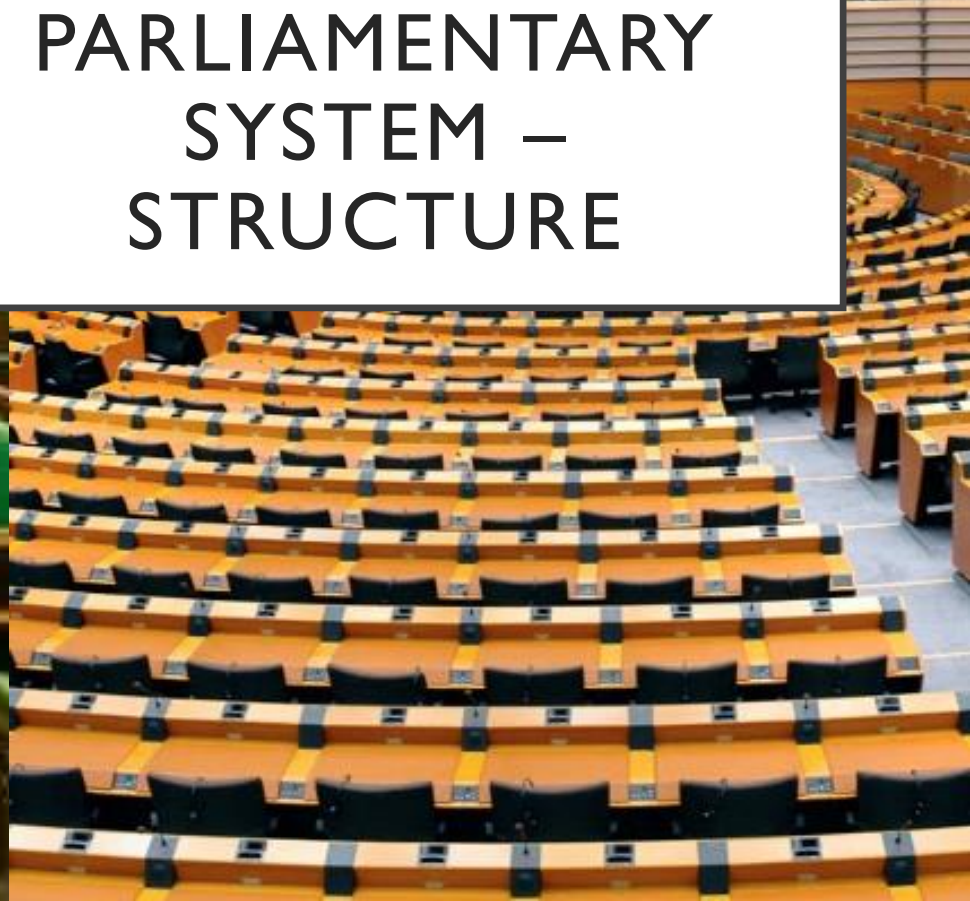

PARLIAMENTARY SYSTEM – STRUCTURE



SCOTTISH BILLS PROPOSERS

- Member's Bill (M): Introduced by a Member of the Scottish Parliament
- Committee Bill (C): Introduced by the Convenor of a parliamentary Committee
- Private Bill (P): Introduced by an external person, company or group of people
- Hybrid Bill (H): Introduced by Cabinet Secretaries

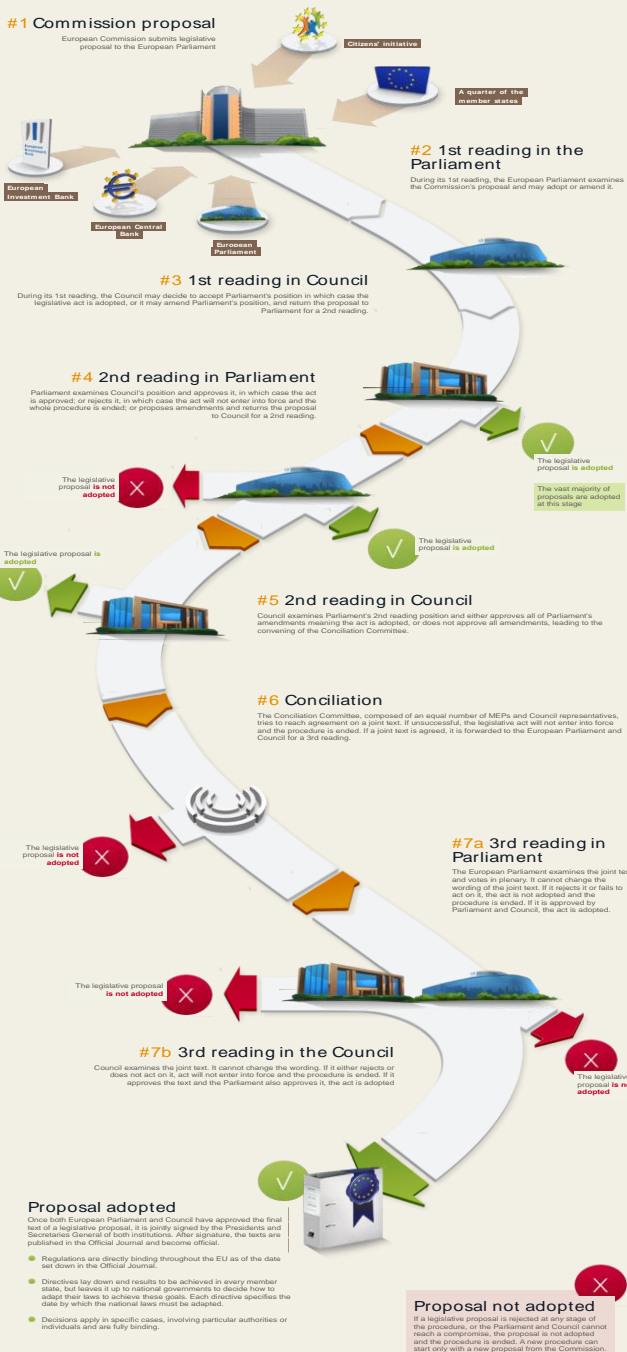
SCOTTISH BILLS PATHWAY

- **Stage 1** - consideration of the general principles of the bill by parliamentary committee(s), and a debate and decision on these by the Parliament.
- **Stage 2** - detailed consideration of the bill by parliamentary committee(s). Two days before a bill will be considered in committee, the clerks prepare a Marshalled List of amendments, which is posted on the bill's web page.
- **Stage 3** - final consideration of the bill by the Parliament and a decision whether it should be passed or rejected

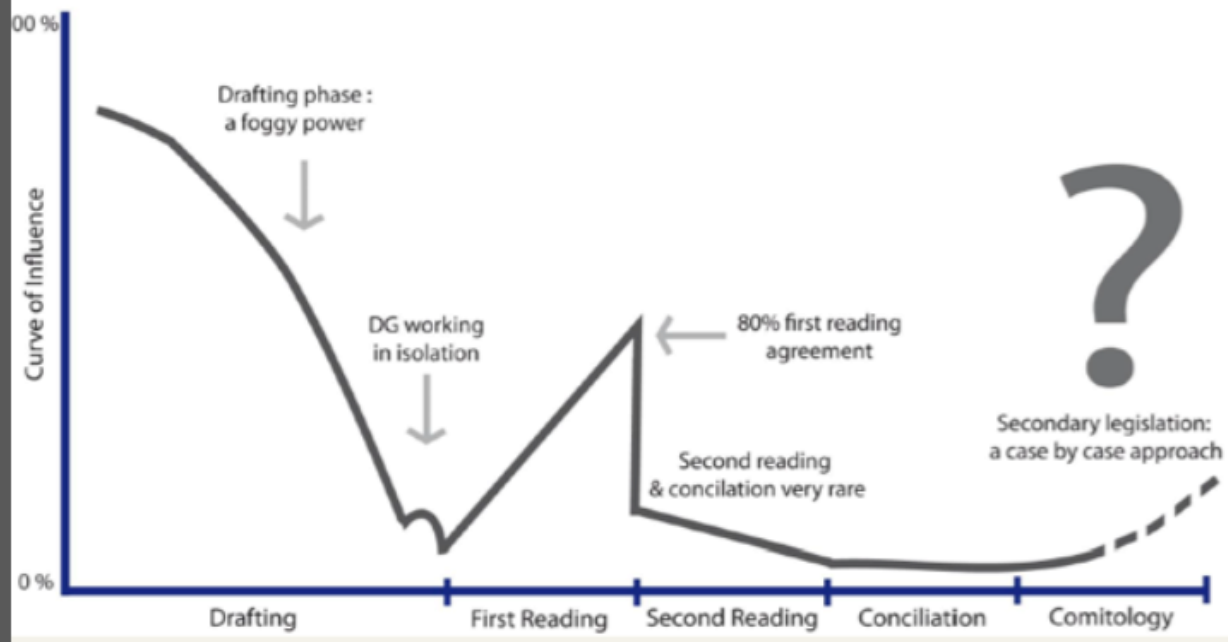

- having regard to Article 294(2) and Article 43(2) of the Treaty on the Functioning of the European Union, pursuant to which the Commission submitted the proposal to Parliament (C7-0211/2012),
- having regard to Article 294(3) of the Treaty on the Functioning of the European Union,
- having regard to the opinion of the European Economic and Social Committee of 14 November 2012 ⁽¹⁾,
- having regard to its resolution of 22 November 2012 on the conservation of fishery resources through technical measures for the protection of juveniles of marine organisms ⁽²⁾,
- having regard to Rule 55 of its Rules of Procedure,
- having regard to the report of the Committee on Fisheries (A7-0256/2013),

EUROPEAN LINKS

Recommendations on fisheries management matters. This may include advice on conservation and socio-economic aspects of management, and on simplification of rules. Advisory Councils are consulted in the context of regionalisation. Advisory Councils should also contribute to data for fisheries management and conservation measures.

In addition to the seven existing Advisory Councils below, the new CFP foresees the creation of four new Advisory Councils for the Black Sea, Aquaculture, Markets and Outermost regions.

Advisory Councils are composed of representatives from the industry and from other interest groups (with a 60% - 40% allocation of the seats in the general assembly and the executive committee). They receive EU financial assistance as bodies pursuing an aim of general European interest.

Who are we and what are our objectives?

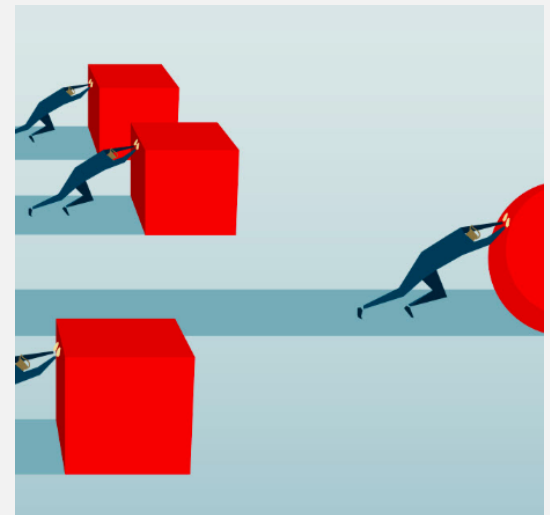
The European Association of Fish Producers Organisations (EAPO) represents 39 POs from 10 EU Member States, with approximately 10,000 vessels, 3.5 million tonnes of landings and € 3 billion first sale value. EAPO was founded in 1980. Every Fish PO recognized by its EU member state can apply for membership of the association.

EAPO's objectives are the following:

- To assist the members in fulfilling their key role as a PO to achieve the objectives of the Common Fishery Policy and the Common Market Organisation for Fishery and Aquaculture Products.
- To provide advice to the members on the management of their Production and Marketing Plans.

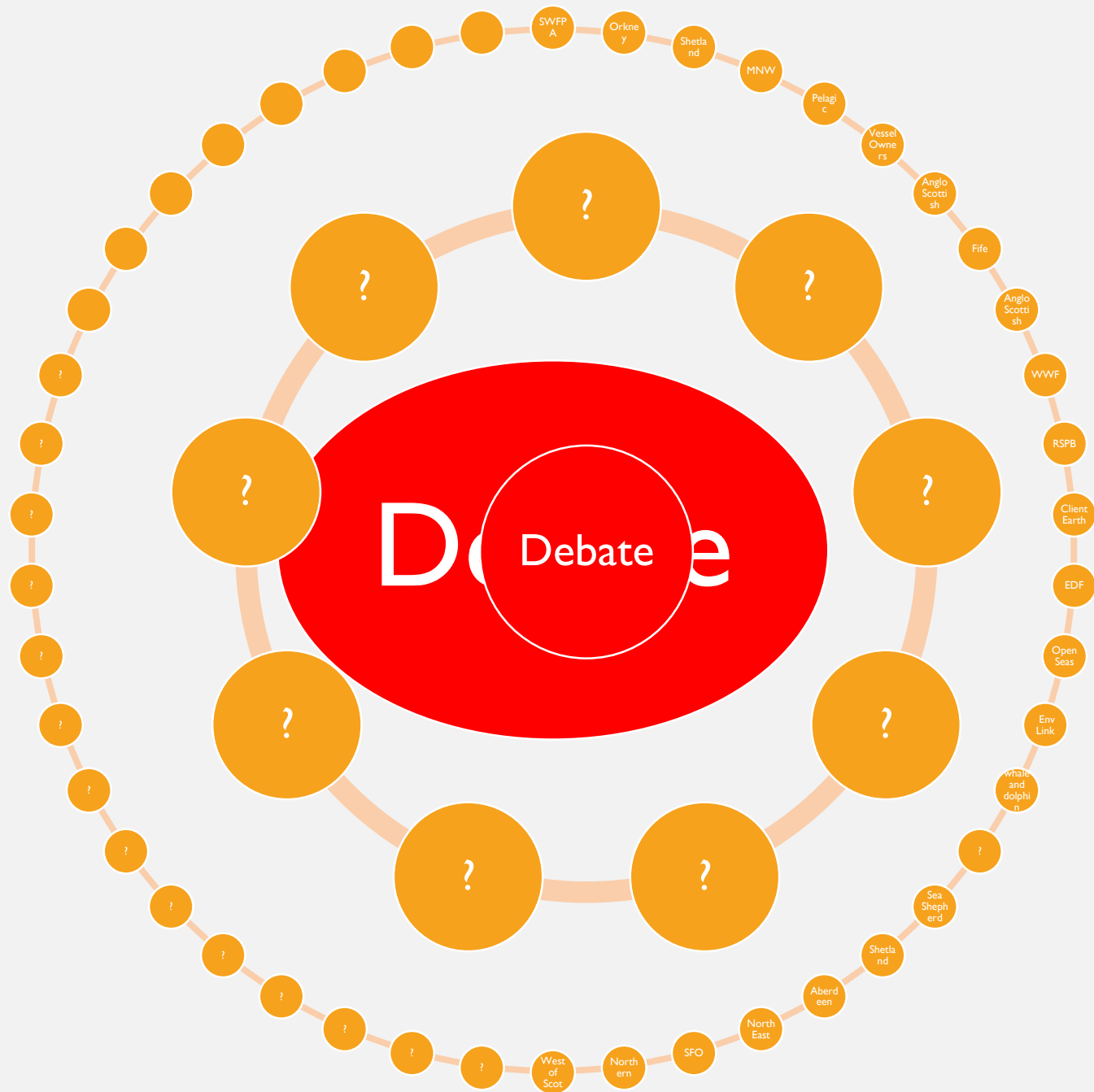

Positive Influence - Examples

- Closure first appeared in EU legislation in 2001
- Removed from the Commissions current proposal for a new Tech Con Regulation
- Currently proceeding through the European parliament





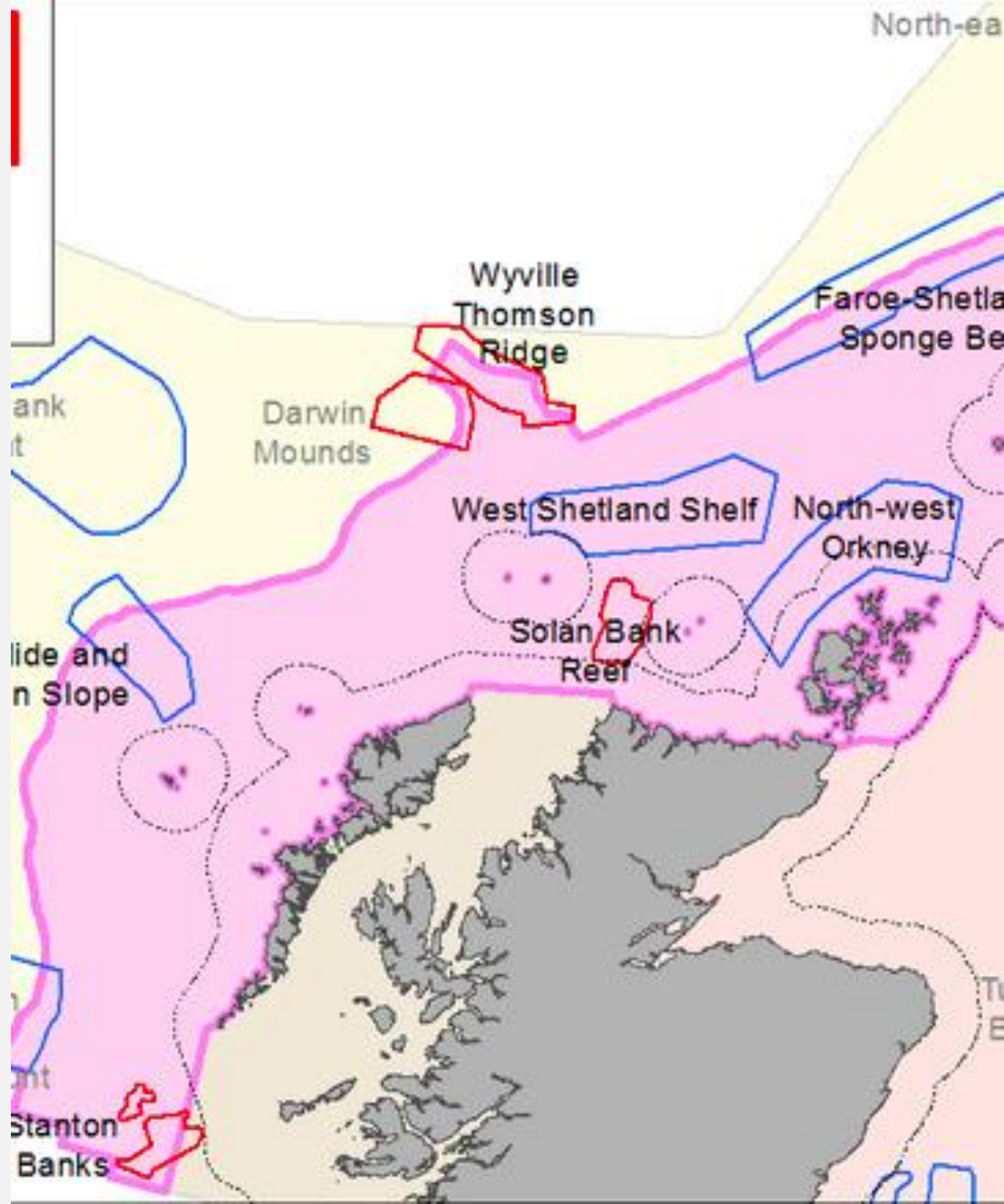
POSITIVE INFLUENCE - EXAMPLES

- EU regulation on the mackerel fishery dictated that 70% of the mackerel quota had to be taken west of four degrees during the quarter one fishery
- An opportunity arose when the three Coastal States, EU, Norway and Faroe Islands were on the cusp of signing a mackerel agreement for the years 2014-2018. Now set at 40%

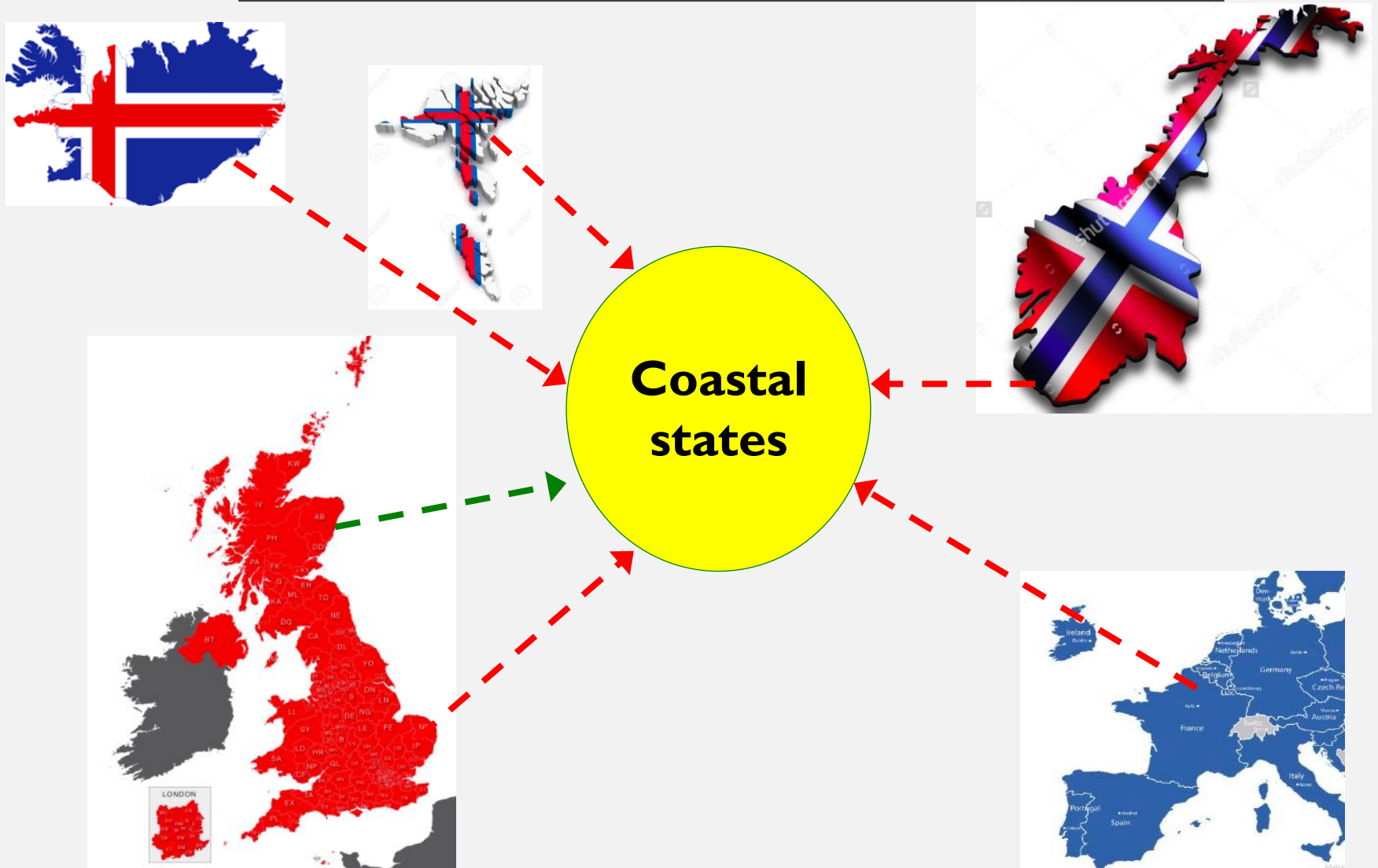


POSITIVE INFLUENCE - EXAMPLES

- Industry worked closely with the authorities to minimize the areas to those of least economic impact
- Industry position heavily dependent on fishers data
- Fishermen heavily involved in discussions
